

Application for Loan Relief Program Completion Payment

Alberta Student Loan Relief Program

Information and Instructions – Please read carefully.

What is the Loan Relief Program Completion Payment?

The Loan Relief Program Completion Payment is the final payment of the Alberta Student Loan Relief Program. It is awarded to qualifying students at the end of their studies. This payment reduces a student's overall debt when it comes time to pay back their student loans.

Who is eligible for the Loan Relief Program Completion Payment?

To be eligible for the Loan Relief Program Completion Payment, you must:

- have completed (graduated or left) full-time studies, and
- have an Alberta Student Loan, and
- have exceeded the minimum debt level for your program.

How is the Loan Relief Program Completion Payment paid?

The Loan Relief Program Completion Payment is an **automatic payment** at the end of your studies only if:

- you received Alberta Student Loans after July 31, 2001, **and**
- you confirmed your final year of studies on your last Alberta Application for Financial Assistance.

The payment is applied directly to the principal owing, then to interest owing, on your Alberta Student Loans at EDULINX and/or your lending institutions. If you have paid off your Alberta Student Loans in full, a cheque will be sent directly to you in the amount of your payment.

What if I did not confirm my final year of studies?

If you did not confirm your final year of studies on your last Alberta Application for Financial Assistance, the Loan Relief Program Completion Payment will still be paid automatically; however, not until at least 6 months after your last month of studies.

You can avoid the minimum 6-month waiting period by printing off, completing, and mailing this application to Students Finance (address below).

How do I complete this application form?

1. Sections 1 and 2 must be completed by you.
2. If you cashed Canada Student Loans before August 1, 2000 at a lending institution other than CIBC or Royal Bank, have your lending institution complete Section 3. Otherwise, leave this section blank.
